Trusted Care will be licensed as a 3-4 adult family home. We will serve residents 24/7, 365 days a year, providing nonstop care throughout the year. Our goal is to have two permanent residents, and two respite beds available. Trusted Care Respite Program will provide care to people living with Alzheimer's, schizophrenia, and dementia. We want caregivers to have peace of mind when they leave their loved ones in our care. It is a priority that Trusted Care provides exceptional care to our clients in a safe and loving environment. Our respite care services give clients an opportunity to interact with others having similar experiences, spend time in a safe supportive environment, and participate in activities designed to match personal abilities and needs.

IProgram Description:

Urban Angels Traveling Playcare will present a win-win family social experience for caregivers and their children during special events and community activities. One Playcare Strategist, along with six confidence coaches customize structured and timed playdates focusing on social skills and daily living for age groups (7-12), (13-17), & (18-21). All activities will take place inside an RV and Activity Tents. Structured play is divided into manageable parts and is carefully sequenced to offer a progression of skills. Our Respite Experience is non-medical and with a ratio of 1:3.

This program will be a new service offered by Rainbow Institue of Learning Inc, a nonprofit agency.

The program can accommodate individuals with various medical needs, such as those requiring assistance with medications, individuals with tracheostomies (trachs), or individuals with complex medical conditions that may require specialized care.
