

Before the 2024 WI Respite Summit, staff disseminated a statewide survey asking participants what they would like to learn during the Summit. A common theme in the surveys was respite care in rural areas. To help attendees learn **what is currently being done** across the state and cultivate more ideas of **what we can do** in the future, RCAW staff helped a World Café gather information. Below is the information that was gathered.

1. Identify actions organizations are **currently doing** or **could be doing** to offer **access to transportation to and from respite activities**. Be specific.

Currently Doing:

- Offices in rural towns or off-site

Could Be Doing:

- Off-site offices in rural areas
- Outreach employees
- Increase broadband and learning technology
- Advertise: meat raffles, farmers markets, food pantries, meal sites, bars, grocery stores, churches, gas stations, doctors, and caregiver coalitions
- Get it to chambers (incentivize program for people to help promote)
- Invite 211 to learn about respite
- Promote WIC
- Dedicates outreach to rural ADRCs
- Encourage ADRCs to host Lunch and Learn events teach and educate to become a provider
- Rural college high schools
- Continuous outreach staff for hospital staff re: ADRC
- Using social media
- Work of mouth think about how to encourage word-of-mouth
- App
- Press event webinar and put info in newspapers
- Use news sources
- RCAW could use our BOD or ask organizations if they are attending conferences etc. to bring our materials
- Ask for specific people in each county incentives

- 3. Identify actions organizations are **currently doing** or **could be doing** to **increase the number of respite providers** in rural areas of Wisconsin. Be specific.

Provoking thoughts to help kickstart conversation if needed.

- Wisconsin Respite Care Registry offering continuing education
- How could we encourage providing respite as a profession?
- Are we missing any untapped pools of potential providers?

Currently Doing:

- Sauk County has the "Helping Hands at Home" program. ADRC runs background checks. They have 35 workers on their list who provide supplemental and direct respite services.
- Marshfield has "Tiny Tigers" program ½ child and ½ adult day services. Local college students come in to assist with adult programming.
- Utilize NWCEP, ICAA, Western Dairyland, and Workforce resources for small business development.
- Other ADRCs put monthly ads in newspapers, presentations at local churches, free lunch/zooms, search Indeed, incentivize taking RCPT/CPR w/ \$ to look for respite providers.
- State provider management list

Could Be Doing

- Competitive pay (over \$15/hr) and better benefits
- Transportation a lot of providers live outside rural areas volunteer drivers, car rental/gas cards (some ADRC counties help with this)
- Thorough training
- Set up booths at local fairs, colleges, libraries
- Present to groups that may be interested in being a provider as a part-time job (because of lack of benefits and consistent pay)
 - Colleges and UW extensions in rural areas (particularly classes for therapies, nursing, social work, education), WREA/WEAC (retired teachers), paraprofessionals, retired health care workers, religious organizations, Tiny Tigers (educate about respite outside daycare), small businesses incubators
- Partnerships with colleges for college credit to provide respite
- Collaboration among agencies for flexible scheduling some central coordination
- Advocating for respite under Medicare/Medicaid

Goal: Increase Respite in rural areas of Wisconsin World Cafe

Provoking thoughts to help kickstart conversation if needed. Actions like:

 - Number of primary caregivers in rural counties
- How might we collect data?
- Who would help in collecting data?

Currently Doing:

- Respite service (providers) collect data
- GWAAR Aging Plan survey and focus groups used for goals of org.
- NFCSP to DHS (Sauk County does separate year and satisfaction surveys shared with county board)
- Family Voices do online zoom meetings listening sessions do in conjunction with events (free dinner)
- ADRCs are moving toward statewide foster care/kinship

Could Be Doing

- How many providers are in the county
- Clearing House to gather data
- Statewide registry of providers
- Data survey of providers w/ info ex.
- Incentives to provide data
- Neighborhood apps to collect data
- RCAW do listening sessions for different groups (CG, providers, agencies, etc.)
- Definition of respite to know who needs respite
- Mail short surveys w/self-addressed envelopes w/ dollar bills or raffle opportunity
- Providers list needed for people training from CLTS to adult
- Providers could provide data
- Homeschool not aware of services
